Short description of the professional and teaching experience including research interests

Daniel Tarschys is Professor emeritus in Political Science at the University of Stockholm. A former Secretary-General of the Council of Europe (1994-99), he has been Secretary of State in the Swedish Prime Minister's Office and a member of the 2000 Convention drafting the EU Charter on Fundamental Rights. As a member of the Swedish Parliament for 15 years, he chaired the Standing Committees on Social Affairs and Foreign Affairs. He has been Vice President of the International Political Science Association (IPSA). Presently he chairs the Boards of Riksbankens Jubileumsfond, the European Humanities University (Vilnius) and the Swedish Research Institute in Istanbul. His publications cover comparative government, public administration, budget policy and political philosophy.
